## Is America On The Verge Of A Financial Meltdown?

Early Tuesday morning October 29, 1929, the stock market opened as usual. The only difference on this particular day was that all the trading activity on the floor was to sell, not buy. Not only did the "crash" that followed affect every American, it affected people and economies all over the world. Millions of people lost their jobs; their homes; and their life savings. The middle class was wiped out in a single day. By the end of the year, commodity markets lost an unbelievable sum of 40 billion dollars in equity (that was in 1929 mind you). Four years later, at the depth of the depression, the national income fell by 50% and 5,000 banks had closed their doors.

How many Americans, even back in 1929, ever thought that could happen? What makes you think it won't happen again?

Due to the suffering induced by the 1929 depression, the new President Roosevelt took action with programs that were illegal. The President boldly initiated his socialistic "New Deal", and for the first time in history, the U.S. government intervened in the affairs of private business with help called "entitlements." Does Government use force to get what they want?

There is no doubt, Government has complete power and authority over you, your life, your family, your loved ones, your rights, your freedom, your future, and everything precious to life. And these days it seems that almost anything we do is illegal unless we first get permission to do it.

If you don't believe me, try hunting or fishing without a license. If caught, you can be arrested, and many have been. Try making changes to your home without getting a permit (permission) from the Government. You can be arrested. Do you have a pet? You better have a license or guess what... you can be arrested. Want to grow a garden in your back yard? Yup, better have a permit.

Where does it end?

Did you know that 40,000 new laws went into effect just in January alone? Did you know this? Every single new law restricts your freedom just a little bit more. The truth is that America has become a systemized form of control where virtually everything that we do is highly regulated and you need permission to do it. Police are more dangerous to the public than are criminals. The worse threat every American faces comes from our own Government. There is no denying it. You hear in the news almost daily about cops overstepping their authority. Do you ignore it? Why? Because it did not happen to you or someone you know?

Are they overstepping their authority? Earlier this year a Missouri man was arrested for the heinous crime of "not wearing a seatbelt" in his car. Oh, did you not know you could be arrested for that? He refused to sign the ticket for such a ridiculous civil charge. So they yanked this man out of his car, tasered and cuffed him, and put him in a cell. Now some of you may be thinking, why did he just not sign the ticket? While we may never know why, it still does not dilute the fact that citizens, like you and I, can be arrested for such stupid laws. Laws we never agreed to in the first place.

Every aspect of the 350 million people in America is controlled by a select few. There are very few things you can do without first getting permission. And, as we already discussed, Government is supposed to have "limited and delegated authority" afforded to them by the people?

Do you think that is how it's working now?

Everything government does is under threat and at the barrel of a gun. Government support is compulsory. People doing business as governments are incapable or unwilling to provide their services to the market on a voluntary basis like normal people so they use guns and threats to make you comply. The level of dishonesty with these "people" knows no bounds. We see it almost daily. We know about the many scandals just our current government has been involved in and yet we still do nothing.

Maybe you don't care to do anything. That is fine. However, one day you will have to look your children in the eyes and explain to them why you did nothing to

There is one thing that separates our Government from any other organization or corporation. It is that governments initiate the use of force to get you to use their services. Nobody else does this. And politics is nothing more than deciding how this power should be used. That's why, when Chairman Mao Zedong (Founder of the People Republic of China) said, "All political power comes from the barrel of a gun," he was not philosophizing or speaking in abstract. He was stating a fact!

Here is a story about a sick woman who was shackled and locked in a cage — all stemming back to a \$5 late fee to the Government. We know you don't know this woman but, we would ask that you read this as if this was someone you knew. Would you be outraged?

In Massachusetts, freedom is so abridged that even simple things like owning a pet require paid permission from the government. It's so onerous that in some municipalities, there are multiple licenses required. Such is the case in Holyoke, where dog owners must pay for permission from both the state and the city - every year.

But asking for permission to own her 14-year-old dog, Pumpkin, for another year was not exactly a high priority for Ann Musser, 41. Musser had been "fighting death" ever since she developed cancer. She recently underwent massive abdominal surgery for ovarian cancer and had been trying to survive a regime of harsh drugs.

She admits that she forgot about the license fee. In her bouts with sickness, she went for a prolonged period without opening her mail. Musser also failed to see any additional notices of her unpaid renewal application.

As a policy, the licensing bureaucrats wait 21 days, and then turn the un-permitted pet owners over to the District Court. Musser became one of them.

Afterwards, Ann and her husband got caught up on their mail, and paid the extortionists the \$5 they demanded plus a \$25 late fee.

But it didn't matter. There was an outstanding warrant hanging over her head. She attempted to see a judge to clear it. She was forced to wait in a long line among many other people in a crowded courthouse, receiving no special treatment for being gravely ill. She felt that her frail health was actually being put in jeopardy due to the stress and germs. Musser has a weakened immune system caused by the toxic chemotherapeutic drugs, and has been directed by doctors to avoid crowds. She decided that three hours of waiting was all she could handle.

Musser decided to go home where she belonged and rest. She hoped the government would figure out that the fee had already been paid and that they would leave her alone. For a few months that worked.

On Friday, March 21st, 2014, a cop pulled over her husband as he entered their driveway. The husband had left his license - a driver's license - inside the house. The officer requested that he go fetch both his and his wife's licenses from inside. Once he ran Ann Musser's license through the system, the warrant appeared and she was told that she was going to jail.

Even though she was inside recovering from a week of bronchitis and high fever, the officer claimed that he had no choice but to arrest her. His conscience could not intervene with his fulfillment of his orders. "I hadn't left the house in days because I was so sick," Musser explained to Mass Live, saying that she was a cancer patient and vulnerable to infection.

Nonetheless, Musser was put into handcuffs, and transported to jail in tears. There she was surrounded by filthy conditions and drug users. She was terrified that the germ exposure would make her sick.

"[Ann] got arrested for a non-crime. Basically for a \$5 fee that was already paid off," said Ozzie Ercan, Ann's husband. "If they can't differentiate between this and serious crime, and treat a sick person this way, then I don't see how they are capable of serving and protecting."

The government apparently can't make that distinction, seeing that people go to jail for petty reasons such as this all the time. Just earlier this month another Massachusetts dog owner was jailed for similar reasons. How else would the courts be so overcrowded if not for petty nonsense?

Apologists for the police state insist that this arrest wasn't exactly due to a dog license or a late fee; it was due to disrespecting the court process. But the truth is that every petty ordinance - and every well-intentioned law - is backed by men with guns who are willing to throw people in cages. Even the most menial license requirement can ultimately make an innocent person's life miserable. And as we have seen, most police officers will follow through with making an arrest, no matter how ridiculous the offense; no matter how unjust the situation; no matter how pathetic the victim.

The most obvious lesson is that society should be extremely diligent and careful about what laws they tolerate remaining on the books. A pet license may seem like a tolerable annoyance to some, but are they comfortable with harassing and imprisoning people like Ann Musser when they fail to comply? If not, the system should be wiped from the books or made into a completely voluntary system. Why should "free people" ask permission to own a dog, anyway?

"Rights are not gifts from one man to another, nor from one class of men to another... It is impossible to discover any origin of rights otherwise than in the origin of man; it consequently follows that rights appertain to man in right of his existence, and must therefore be equal to every man."

The "law and order" conservatives and the "compassionate" liberals stand silent while police psychopaths brutalize children and grandmothers, murder double amputees in wheel chairs, break into the wrong homes, murder the family dogs, and terrify the occupants, pointing their automatic assault weapons in the faces of small children.

The police have been militarized and largely federalized by the Pentagon and Homeland Security. The role of the federal government in equipping state and local police with military weapons, including tanks, and training in their use has essentially removed the police from state and local control. No matter how brutal any police officer, it is rare that any suffer more than a few months suspension, usually with full pay, while a report is concocted that clears them of any wrong doing.

In America today, police murder with impunity. All the psychopaths have to say is, "I thought his wallet was a gun," or "we had to taser the unconscious guy we found lying on the ground, because he wouldn't obey our commands to get up."

It happens people. There is no denying it. It's on video for God's sake and we still argue amongst each other on what really happened.

We remain silent with the erroneous belief that this only happens to minorities or those who deserve it, but psychopaths use their unaccountable power against everyone. Do you think Ann Musser deserved what she got?

In closing, just look at what we observed in the police response to the Boston Marathon bombing. It suggests that the situation is irretrievable. One of the country's largest cities and its suburbs—100 square miles—was tightly locked down with no one permitted to leave their homes, while 10,000 heavily armed police, essentially combat soldiers armed with tanks, forced their way into people's homes, ordering them out at gunpoint. The

excuse given for this unprecedented police action was a search for one wounded 19-year old kid.

That such a completely unnecessary and unconstitutional event could occur without the responsible officials being removed from office indicates that "the land of the free" no longer exists. The American population of the past, suspicious of government and jealous of its liberty, has been replaced by a brainwashed and fearful people, who are increasingly referred to as "the sheeple."

## Our Health Is Not Up For Debate

The Universal Health Care Act (UHC) (often called The Affordable Care Act), passed in March of 2010 and was upheld by the Supreme Court of the United States in June 2012, has been making headlines for the past few years. Today, it's dramatically changing the way health insurance is provided to Americans. This piece of legislation serves up all kinds of new rules about how health insurance affects health care providers, insurers, and consumers like you, now and in coming years

However, has anyone ever asked the question... should the Government be providing Universal Health Care for all Americans?

Our initial reaction was to laugh and maybe you should too. Can you name one single government agency or division that runs efficiently? Do we really want an organization that developed the U.S. Tax Code handling something as complex as health care? They say it will provide free health care but, is it really free since we must pay for it with taxes and these expenses for health care would have to be paid for with, you guessed it, higher taxes.

"Universal Health Care" is politically controlled medicine, with government as the "single payer" insurer. Having coverage does not guarantee getting medical care.

Politically controlled health care in America--Medicaid and Medicare--is already a nightmare. Doctors are five

times more likely to refuse to see new Medicaid patients than privately insured people. Increasing reimbursement rates won't help much--more than two-thirds of doctors reported being overwhelmed by Medicaid's billing requirements, paperwork, and delays in payment. In some countries with such universal coverage, patients die waiting for treatment.

While "universal health care" may provide health insurance, it doesn't guarantee health care. The uninsured are not the problem but instead are a symptom of the real problem: Government meddling in personal choices over how we care for ourselves and our families.

Let me ask you a serious question... Have you read the new Health Care law? I know it's over 2,000 pages and I know it can be boring. Have you read it? Shame on you if you haven't read it yet. This legislation not only affects you, it affects your children and future generations to come. How can you have an opinion on UHC when you don't even know what you are getting?

If you do read it, pay close attention to what it says. Our main concerns were for the parts of the proposed law that were unconstitutional. But, what was found is far worse than what anyone had expected.

To start, much of what has been said about the law and its implications are true, despite what the Politicians and the media are saying. The law does provide for rationing of health care, particularly where senior

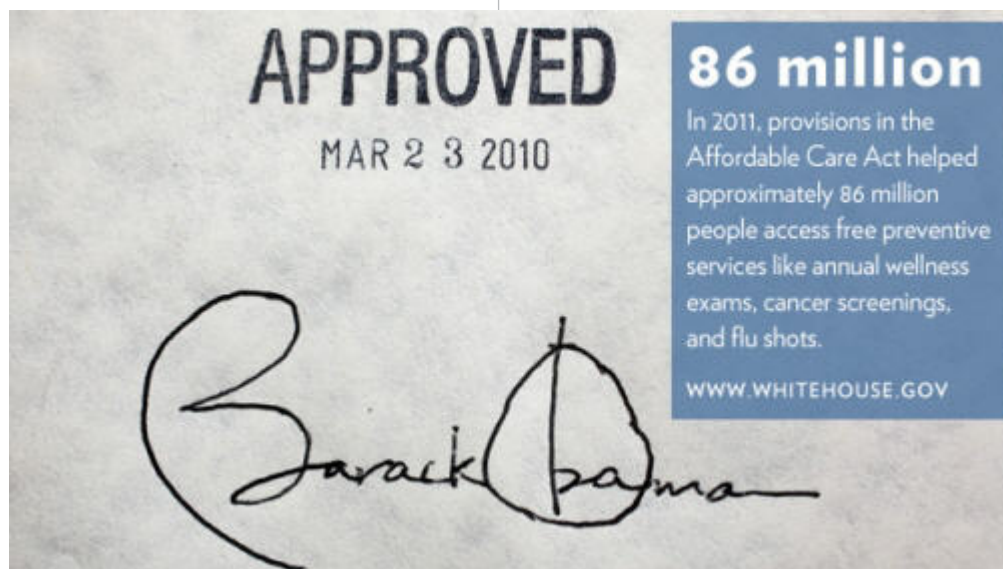
citizens and other "classes" of citizens are involved, free health care for illegal immigrants, free abortion services, and forced participation in abortions by members of the medical profession. Yes, you read that correctly. Welcome to the new Government run program.

The Bill will also eventually force private insurance companies out of business, and put everyone into a government run system. Can you say goodbye free markets? All decisions about personal health care will ultimately be made by federal bureaucrats, and the majority of them will not be health care professionals. Hospital admissions, payments to physicians, and allocations of necessary medical devices will be strictly controlled by the government.

How are you feeling about Universal Health Care now? It gets worse my friends.

As scary as all of that is, it just scratches the surface. In fact, this legislation really has no intention of providing affordable health care choices. Instead it is a convenient cover for the most massive transfer of power to the Government that has ever occurred, or even been contemplated. If this law or a similar one is adopted, major portions of the Constitution of the United States will effectively have been destroyed.

Think about how much Government already runs your lives. Only now they will be running your health care too.





The ironic part in all this... Congress doesn't have any authority to legislate in most of those areas to begin with! I defy anyone to read the text of the U.S. Constitution and find any authority granted to the members of Congress to regulate health care. Are you going to take us up on that challenge?

The UHC bill also provides access, by the appointees of the Congress, in direct violation of the specific provisions of the 4th Amendment to the Constitution, of all of your personal healthcare information, your personal financial information, and the information of your employer, physician, and hospital. All of this is protecting against unreasonable searches and seizures. You can also forget about the right to privacy. That will have been legislated into oblivion regardless of what the Third and Fourth Amendments may provide.

If you decide not to have healthcare insurance, or if you have private insurance that is not deemed acceptable to the Health Choices Administrator by Government, there will be a tax imposed on you. It is called a tax instead of a fine because of the intent to avoid application of the due process clause of the Fifth Amendment. However, that doesn't work because since there is nothing in the law that allows you to contest or appeal the imposition of the tax, it is definitely depriving someone of property without the due process of law.

For those who might doubt the nature of this threat, I suggest they consult the source, the US Constitution, and Bill of Rights. There you can see exactly what we are about to have taken from us.

As the debate on universal health care goes on, I think we all are missing the bigger picture. Government is not the solution, it is THE problem. Anything and everything the government gets involved in will always be performed inefficiently and ineffectively and at a huge cost to the tax payers. Those who think the government brings down the cost of healthcare disregard history. Healthcare was very affordable until the government decided to establish HMO's around the end of the 1970's. Since that time healthcare costs have skyrocketed.

The amount of fraud that is committed and cost of fraud since the government has involved itself in healthcare, or any other project, is beyond ridiculous (hundreds of billions A YEAR).

But now, we live in a society where everyone thinks everyone else owes them a living. It is not the responsibility of the government to ensure every citizen has access to healthcare or a retirement fund (Social security) or food. It's OUR responsibility.

The truth is that you do not have a right to Health Care. Now our only rights are the rights to life, liberty, property, and the pursuit of happiness. That's all. We are not born with a right to a trip to Disneyland, or a meal at McDonald's. Nor are we born with the right to have other people take care of us. It's insane to think you can take from others so you don't have to do anything.

America's original rights have been virtually wiped out, ignored as if they had never existed. The rule now is for politicians to ignore and violate our Constitutional rights, while arguing about a whole list of rights never dreamed of in this country's founding documents—rights which require no earning, no effort, no action at all on the part of the recipient.

This new law moves America's health care system in the wrong direction, transferring vast powers to Government who will control the dollars and decisions that should be in the hands of individual patients and their families.

We must stop Government from wasting the labors of the people under the pretense of taking care of them.

## Who Are You? Do You Know Your Rights? Part 1

You can't defend your rights if you don't know them. Our country's founding documents clearly state all the rights you have. If you haven't looked at these since high school history class, go ahead and check them out again.

Throughout history, rulers and dictators have taken away people's rights. In many parts of the world today people can't worship as they please, talk freely, gather with groups of friends, or travel. If you feel that everyone is always telling you what to do and that you have no rights, you're wrong! It's important to know your rights and to stand up for yourself.



### The Bill of Rights

The Bill of Rights was added to the Constitution in the form of amendments. The chief purpose of the amendments was to protect the rights of individuals from the government's interference. They guarantee rights such as religious freedom, freedom of the press, and trial by jury to all American citizens.

- **First Amendment:** Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances.
- **Second Amendment:** A well regulated militia, being necessary to the security of a free state, the right of the people to keep and bear arms, shall not be infringed.
- **Third Amendment:** No soldier shall, in time of peace be quartered in any house, without the consent of the owner, nor in time of war, but in a manner to be prescribed by law.

- **Fourth Amendment:** The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.
- **Fifth Amendment:** No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a grand jury, except in cases arising in the land or naval forces, or in the militia, when in actual service in time of war or public danger; nor shall any person be subject for the same offense to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation.
- **Sixth Amendment:** In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the state and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the assistance of counsel for his defense.
- **Seventh Amendment:** In suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved, and no fact tried by a jury, shall be otherwise reexamined in any court of the United States, than according to the rules of the common law.
- **Eighth Amendment:** Excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted.
- **Ninth Amendment:** The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.
- **Tenth Amendment:** The powers not delegated to the United States by the Constitution, nor prohibited by it to the states, are reserved to the states respectively, or to the people.

I love it when people get really philosophically intellectual and talk about this." Well maybe they have a philosophical debate about the existence of God and all these things" But that's true, there's nothing to validate and support that. But there's every evidence there is to support the existence of God. And we're not going to get into the debate about that and spend too much time on it because we don't have time and that is not as important.

God created you and me, he created man, he created everything actually. But out of everything that God created, he created man in his image. And he said we will create them man or woman in our image. Now, what does that mean? You can believe what you want to believe, We're not pushing anything, but you have to have a foundation. The US Constitution is a document firmly founded in the principle of Enumerated Powers. The document is meant to set forth the "limited powers" that the People were granting the government "to protect and maintain

rights, provide for the common defense, and secure our Liberties."

The important thing to keep in mind is that the people who have created their government can give to that government only such powers as they, themselves, have in the first place. Obviously, they cannot give that which they do not possess. So, the question boils down to this. What powers properly belong to each and every person in the absence of and prior to the establishment of any organized governmental form? A hypothetical question? Yes, indeed! But, it is a question which is vital to an understanding of the principles which underlie the proper function of government.

This means, then, that the proper function of government is limited only to those spheres of activity within which the individual citizen has the right to act. By deriving its just powers from the governed, government becomes primarily a mechanism for defense against bodily harm, theft and involuntary servitude. It cannot claim the power to redistribute the wealth or force reluctant citizens to perform acts of charity against their will. Government is created by man. No man possesses such power to delegate. The creature cannot exceed the creator.

In general terms, therefore, the proper role of government includes such defensive activities, as maintaining national military and local police forces for protection against loss of life, loss of property, and loss of liberty at the hands of either foreign despots or domestic criminals.

Is that how things work now? Do we have limited Government? The federal government has grown exponentially, not just in spending, but in its reach. Government intrudes into virtually every aspect of our daily lives, from the type of toilet we can buy, to the mix of fuel we put in our cars, to the kind of light bulb we can use. We have to get permission to fish, hunt, drive a car, open a business. For God sakes, we have to get permission to own a pet. Is that freedom?

It's amazing that we think letting government tell us what to do, when to do it, how to do it and with whom you can do it is a good thing. We live in a country where two percent of the population dictates to the 98%. Is that freedom?

Is our Constitution under siege? There are provisions tucked into the 2012 National Defense Authorization Act, that was approved by the Senate, that would allow the military to detain, without a trial, any American citizen accused of being a terrorist, or of supporting terrorists who plot attacks against the United States. The NSA is reading every one of your emails and listening to all your phone calls.

Feel like you have any power now?

So, why does government have all the power? How did things get this way? Do you think that the government has a secret weapon?

**Everything our government does to us is under threat and at the barrel of a gun!**

Those in the government have complete power and authority over you, your life, you family, your loved ones, your rights, your freedom, your future, and everything precious to life. If you don't believe me, try going hunting or fishing without a license. If caught, you can be arrested. Want to make some updates to your own home? Better get a permit (permission) from the Government. Or you can be arrested. Do you have a pet? You better have a license to own that pet or guess what... you can be arrested. There is one thing that separates our government from any other organization or corporation. It is that governments initiate the use of force to get you to use their services. Nobody else does this.
